

**G3 TERMINAL VANCOUVER
FIRST NATION ART CALL - GRAPHIC DESIGN
COMPETITION RULES**

1. The First Nations Art Call (the “FN Art Call” or the “Call”) begins on February 20, 2020 and submissions must be received by 4:00 p.m. (Vancouver time) on August 30, 2020 (“FN Art Call Period”) to be eligible. This Call is conducted by G3 Terminal Vancouver Limited Partnership (“G3TV”).

2. One (1) cash award of \$10,000.00 (CDN) (the “Award”) and payable in one sum on or before October 31, 2020. In addition, if the successful Youth Artist (as defined below) has previously identified a Mentor who has partnered with the Youth Artist, that Mentor shall be awarded an honorarium of \$3,000.00 (CDN) payable in one sum on or before October 31, 2020. The cash prize and the honorarium cannot be paid to the same individual. For the purpose of this FN Art Call, a “Young Artist” shall mean a person under the age of 30 as of August 30, 2020.

3. To be eligible to participate in the Call, each Youth Artist must meet the following requirements: (i) be under the age of 30 as of August 30, 2020; (ii) be a member of one of the Musqueam, Squamish or Tsleil-Waututh First Nations; (iii) be a resident of Canada; (iv) complete the FN Art Call submission requirements as outlined in the G3 Terminal Vancouver - FN Art Call document dated February 20, 2020 and revised on Monday, March 30, 2020 and Thursday, June 25, 2020; (v) submit all accompanying documents as outlined in the submission requirements (including the Subscription Form and Agreement); and (vi) produce and submit an original graphic design. The graphic design must be:

- i. a new, unique, original work created by the Youth Artist
- ii. easily reproduced and recognized in black and white or in color
- iii. work well in both print and digital mediums
- iv. have clearly defined shapes and line art
- v. scalable in order to be used on a variety of products
- vi. reflect the Musqueam, Squamish and/or Tsleil-Waututh culture and art forms.

4. A maximum of one (1) honorarium may be awarded. G3TV reserves the right to refrain from selecting any graphic design and award no honorarium.

5. The winning Youth Artist will be chosen by a Selection Committee. The Selection Committee will make a decision in its sole discretion.

The Selection Committee will be comprised of individuals chosen by G3TV and may include personnel of G3TV. The Selection Committee will review all submissions which will be provided to it anonymously (the Youth Artist’s identity will not be made known to the Selection Committee). The Selection Committee will recommend a short list of up to five (5) designs which will then be ranked individually by each member of the Selection Committee. The rankings will then be reviewed by the Selection Committee and the design that is determined in by the Selection Committee to be ranked the highest shall be deemed to be the winning submission. Submissions not selected as the winning submission will be returned to the Youth Artist.

The decision of the Selection Committee shall be final and binding

6. Submissions will be reviewed by the Selection Committee between August 30, 2020 and September 30, 2020. Only the successful submission will be notified by the Selection Committee. The Award will be presented to

the winning Youth Artist by a designated representative of G3TV.

The time, date and location of the presentation of the Award is to be determined. Before being declared a winner, the selected Youth Artist must be in full agreement and compliance with these contest rules. The selected Youth Artist will be required to sign a grant of license document prior to collecting the Award. A selected entrant who cannot be contacted or who does not agree or comply with these contest rules will be disqualified. An alternative winner may or may not be chosen by the Selection Committee.

7. G3TV shall have the right at any time to require proof of age, identity and/or eligibility to participate in the FN Art Call. Failure to provide such proof in a form satisfactory to G3TV may result in disqualification. All personal and other information requested by and supplied to G3TV for the purpose of the FN Art Call must be truthful, complete, accurate and in no way misleading. G3TV reserves the right, in its sole discretion, to disqualify any entrant should such an entrant at any stage supply untruthful, incomplete, inaccurate or misleading personal details and/or information. G3TV is not responsible for any change of email address, mailing address and/or telephone number of entrants.

8. By entering this FN Art Call, the entrant agrees to abide by all of the Call rules and the decisions of G3TV and the Selection Committee, which are final.

9. Employees, representatives and agents of G3TV or FleishmanHillard Highroad and each of their affiliates, as well as the immediate families (legal or common law spouses and children) of each of these employees, representatives and agents are not eligible to enter the FN Art Call. This call is subject to all Federal, Provincial and Municipal laws and regulations.

10. G3TV, including its their agents and representatives and those associated with each of them, are not responsible for any entry form, prize winning notice or prize claim that is late, lost, stolen, delayed, misdirected or illegible, whether or not due to the fault of G3TV or of any other person or thing. G3TV is not responsible for any failure of the submission email (if any) during the FN Art Call period, for any problems or technical malfunction of any telephone network or lines, computer on-line systems, servers, access providers, computer equipment, software, failure of any e-mail or entry to be received by G3TV on account of technical problems or traffic congestion on the Internet or at any website, or any combination thereof. G3TV reserves the right at their sole discretion, to disqualify any individual (and all of his or her entries) who tampers with the entry process.

11. G3TV reserves the right to cancel, terminate, modify or suspend this FN Art Call, or extend the deadline for this Call, at any time for any reason. If the FN Art Call is terminated or suspended, the Selection Committee may select the winner by a random draw from eligible entries received before that time.

12. The award must be accepted as awarded, is not transferable. G3TV will make all reasonable efforts to deliver the prize to the declared winner as soon as possible after a decision is made.

13. The winner is responsible for, and releases G3TV and its affiliates and advertising agencies from, all claims, injuries, damages, losses and costs related to or in any way

arising out of this FN Art Call (including, without limitation, the delivery, acceptance, insurance and use of the award). The winner will be required by G3TV to execute a release and indemnity form in favor of G3TV.

14. Under no circumstances will G3TV or any of its directors, officers, and employees, be required to award more awards than what is indicated in these rules or award the Award other than in accordance with these rules.

15. By completing the FN Art Call submission, the entrant consents to the collection, use and disclosure of his/her personal information by G3TV for the purposes of administering this FN Art Call and as permitted by the Call rules, and to the collection and use of such information by

G3TV and the disclosure to and use of it by G3TV and its affiliates in accordance with the G3TV's Privacy Policy.

16. By entering this FN Art Call, the entrant agrees to the use, without compensation, of his/her photograph, name and in all publicity campaigns related to the FN Art Call, including in all advertising and news releases and on G3TV's or its affiliates' websites, social media pages, and in the G3TV's or affiliates' online and paper newsletters.

17. SUBJECT TO THE LAWS OF BRITISH COLUMBIA.
